### Permission for Photography

I specifically consent to the digital compositing or distortion of the images, portraits, pictures, or video without restriction to any changes or alterations as to color, size, shape, perspective, context, foreground or background. I also consent to the use of any published matter in conjunction with such images or video. I hereby waive any right that I may have to inspect or approve the finished product or products and the advertising copy or other matter that may be used in connection with said images or video or the use to which they may be applied. Images will be selected at the sole discretion of the Photographer and the final set of edited .jpg images will be presented to me via on-line galleries. All images and video will remain the intellectual property of Jim's Photos, LLC and copyright in his own name or otherwise. I may not alter, crop or change the images without the consent of the photographer.
